

I am to be seen here outside the Tabernacle venue, January 2020.


The sign is a parody of the Westboro Baptist Church's font and format when protesting events.

How I started reading arguments for curing autism and their leading to beliefs over what causes 'it', if you accept you can relate to NeuroDivergence in terms of a cause other than it being hereditary. How frames of reference started putting people's lives in danger.

This because I wanted to demonstrate how easy it was to refute what these people are saying without resorting to proper medical authoritative, verified sources. The entire world of this cult seems to me to be that shallow. If there was any greater depth it would have influencing authority in our world. It only has the capacity to make people not actually take vaccines. But what I want you to consider, is just how much influence over all of us it is gaining right now.*

## **PART ONE. WHAT IS THIS DOCUMENT** **AND WHY DID I WRITE IT?**

**I DID NOT WANT TO WRITE THIS DOCUMENT. (This by way of an introduction).** I swear I had had enough after the 2016 film Vaxxed one. The only reason I abandoned extending and enriching that was because it seemed to me you could never stop criticising and undermining it. Also I did not think it was a healthy pursuit, thinking too much about a pack of lies. Or rather, paranoid conspiracy theory medical science fiction.

But then came January 2020, and I joined Emma Dalmayne and ten other fine autistic people in protesting at the screening of Vaxxed 2 – the people’s truth at the Tabernacle Venue in Powys Square, West London. Within weeks of this happening, Covid 19 virus had shut down the planet. All of it. One virus for which no one had a vaccine.

Still I resisted. The whole thing was a sick joke to me. The people involved, arrogant intellectual snobs and touting a bizarre attitude of “Parents and Professionals are the only people who know about Autism’.

Check the Autism One conference and the opinions of just about any of the hard – cure supporters of Andrew Wakefield and his cult. Yes it is a cult. Also the overall Anti Vaxx movement in whatever form it takes and whatever names it gives itself. Trust me it’s the same attitude. The idea that many parents are actually undiagnosed autistics never seems to occur to most of them. The few that do sign up for the faith that they were brain damaged by vaccines and so where their kiddies. Always a way of seeing things your way if you know how you know? More of that later.

Finally the luxury of having so much time to myself on furlough, together with actually having the entire film to look at, caused this document to happen.

**PROOF OF MANY OF MY CLAIMS ABOUT WHAT HAPPENED AT THE VAXXED 2 SCREENING IN LADBROKE GROVE, JANUARY 2020 CAN BE HEARD ON THE FIRST EVER GUERILLA ASPIES PODCAST.** I interviewed and recorded people there and then. You can hear this on Itunes, Acast and Soundcloud. PAUL WADY GUERILLA ASPIES PODCAST. Simple. 😊

**THE CULT ITSELF PROCEEDED TO RECORD AND INTERVIEW THE PROTESTORS, AND EVEN MYSELF.** They did this via a two woman camera crew who lied point blank to my friends and myself that they were nothing to do with Vaxxed. Later on as one of the women ran into the venue she admitted she had lied by just saying yes, then disappeared. They maintained the usual supercilious and strangely superior, ‘freedom fighters against the evil oppressors’ attitude they all seem to have. Mindset mindset.... The full event was captured on my **Paul Wady Guerilla Aspies podcast number one**. Just have a listen. Proof proof proof.

The same two women were spotted doing the same thing at one of the 2020 Trafalgar Square rallies. What was their mindset? How did these two silent women relate to what they were doing. If they were not representatives of a cult mentality in their reticence to explain anything about themselves, what does such a thing look like then?

**I HAD NO INTEREST IN POLITICS OR ACTIVISM UNTIL I WAS DIAGNOSED AUTISTIC.** After my 2004 diagnosis I read, sure. I started planning what sort of a book I wanted to write around 2005. It was the content of the books I found that inspired me. As with what was missing from them. But my activism was caused by finding individuals and groups that were making a point of trying to influence society over autism, in ways I either agreed or disagreed with.

But hold on? Isn't this supposed to be about...autism? If NeuroDivergency is a mental illness or disability, why has it inspired such debate? Why are there lobbies of people with strongly held beliefs around 'autistic things', that define themselves as groups and movements and are in opposition to other groups? How can a mental condition organically generate global politics and debates that have led to a field of representation and politics that have never existed before.

I thought it was just an illness? A disorder of the mind? I had no idea about autism until I saw the film Rain Man in 1996. It looked like he had something wrong with him back then. This poor man who behaved like a stuck record, trapped in his obsessional anxieties. Trying to calm himself by following his passions. But now I see that an entirely different frame of reference was all around and even within me, all my life. All things Autism, to use the term in one of the many different ways it can and often is, are not simple. People go to war over them.

Neurodivergency is clearly not just nothing more than a specialist medical field to do with a condition that needs curing. No matter how much the Wakefield Cult<sup>1</sup> tries to champion the longstanding, historic perspective that world contains either well or sick people, and there is nothing else involved. I refuse to believe that anything around Neurodivergency is that simple. **There is too much proof to be found in the writings of the autistic, and on the internet. Too many social and civil rights movements and activism specific to being autistic alone. Too many people communicating remotely and/or meeting face to face on the basis of being autistic. Too many autism specific debates, arguments and even ideological conflict in the world, exclusive to the autistic and those debating their lives.**

All that is nothing more than a brain disorder? Ever seen another disorder, condition or disease of the mind that has brought all of this about in the space of a few decades of history?

As usual, the cult has framed 'autism' as nothing more than the above. With no references to terms like Neurodiversity, Neurodivergence or the growing Neurodivergent self - advocacy community. Well none of it is part of their reality, is it? It is as if the exploding online culture, the books people like myself have written and the public speakers and out – autistic academics now present all over the planet, do not exist. It's just about the severely mentally disabled for them.

That and the only way you get to be like me is if you are brain damaged by vaccination or pollution in the environment. As opposed to being an ideal of mental health that is discussed at the very end of the film in some detail.

<sup>1</sup> Yes, a cult. I explained this in the Vaxxed One document. An organised membership group based around a common faith, complete with leaders, 'cult guru's' and an ever - enriching set of doctrines and beliefs. Regular meetings, communication and relationships formed on the basis of the group. Yep, it's all there. Fanatical faith - based behaviour.

**THE FILM CONCLUDES WITH A VERY DETAILED AND DISTURBING EXPLORATION ABOUT WHAT IT IS TO NOT BE AUTISTIC OR HAVE MENTAL DISABILITY.** I have never seen anything like it. I would love to hear from any readers if they have either. It is described at the end of this documents part two. It seems that all children who don't have these factors are, without exception in the film, the most intelligent and physically healthy people you can possibly be. The Übermensch as Nietzsche once put it, which was a concept that fell into common parlance with another political group of the 20<sup>th</sup> century that rose to prominence in Germany.

They loved the idea of genetic racial purity you know? I saw a poster of Nordic features when I visited the Museum of Germany in Berlin about 5 years ago now. At that time there was a perfectly acceptable and educated attitude to genetics. Which as we all know led to the science of Eugenics.

Nowadays, we talk a lot about outlawing discrimination. Then, they loved it.



They also had views on the mentally and physically disabled, too.



I found this original copy of this poster in the Museum of Germany in Berlin. It was commonly displayed around the country to promote the Nazi parties monthly magazine Neues Volk and complained about the amount of money a 'useless eater' like this man cost the country. I think it speaks for itself without any need of translation. But here it is: "This hereditarily ill person will cost our national community 60,000 Reichmarks over the course of his lifetime. Citizen, this is your money."

**THIS IS NOT SIMPLY A FILM ABOUT A CONDITION OF THE BRAIN.** The film is only partially about 'autism' as they use the term. That is seen as one side effect of vaccine damage. But if we consider that groups of autistic people have come together to protest about the Cult's work, and that over all these years it's virtually impossible now to divorce vaccination safety debate from the term autism and all it entails, you see my point? The autistic community all over the world, people who would I suspect have had little if any interest in vaccine safety have been dragged into a sort of indirect confrontation with issues around vaccines.

Did autistic people want to be associated with vaccine brain damage? My point is that due to vaccines being attributed as causing autistic natures, an entire world of 'autism politics' has been linked to the Wakefield Cult. I beg you to step back and distance one from the other. Autistic self - advocacy was about acceptance and empowerment of a people who define themselves by their autistic natures and hold them in common. Vaccine damage is a medical issue, restricted to the organism exposed alone. The connecting of one to the other is refuted by me. Yet here I am, writing a piece about a film that tries to make out my nature could be one of brain damage that could have been avoided.

Throughout the film, behind the scenes as it were, an overarching presence lurks. A long - standing attitude that Cult members will not abandon. **THINGS SHOULD NOT BE LIKE THIS.** A denial of the reality of people being born a certain way and then having to make the best of this they can.

With no references to terms like Neurodiversity, Neurodivergence or the growing Neurodivergent self - advocacy community. Well none of it is part of their reality, is it?

**WHAT EXACTLY IS GOING ON HERE?** This section will be reprinted at the end of the document. In order to have it's full effect. I want to include it here at the start in order to prime your perspective. One reason I am writing this thing is in order to demonstrate that this whole business, the films and the cult that produced it, are part of a bigger malaise in our society.

Okay, so people think their children were vaccine damaged. A tiny group involved even think that they personally were. The brave freedom fighters against the evil empire (Big Pharma, Deep State, the NHS etc...No really. Del Bigtree actually wrote online of **THE DESTRUCTION OF DR WAKEFIELDS CAREER AT THE HANDS OF THE BRITISH NATIONAL HEALTH SERVICE.** Please see my write up on Vaxxed One).

Simple, right? Like a film. Good guys and bad guys.

In fact so simple that people are persuaded....to join the good guys. Everything is okay. Boo hiss the bad guys who rule the world, like evil Billionaire genius Bill Gates and his vaccination programmes! The whole world must wake up!

Or is it.

As you will read over and over in these documents, there is something a bit odd going on with the general appreciation of what I term 'adult reality'. I really do think it's all got a lot to do with tv and film. The great Disney binary of children's entertainment, (good guys/bad guys. Nice/cruel. Good and Bad as clearly defined things in all respects. Childlike, simple ways of seeing the world). coupled with the overarching grief and trauma of parents who believe their children were damaged by the very thing they trusted to protect their bodies.

But look again at this document. Think about what you have absorbed? Consider how much the world IGNORES all of this. To the point of DISMISSING all these apparently sincere, first - hand testaments? Don't you see a disconnection here?

**YOU DO ALL REALISE THIS IS A SUB – SUB LEVEL OF MEDICAL ENQUIRY COMPARED TO THE GLOBAL REALITY OF CONVENTIONAL MEDICINE?** I mean it certainly looks like a ground – up discovery of something that is being ignored. But who is doing the research here?

If you are a medical professional I would expect you to ignore this entire piece. You are no doubt part of an ethos that is such that anything written by someone like myself, with a complete absence of medical credentials, is to be disregarded compared to someone who has. Good for you. **Point is however that as you will see, the world of the Vaxxed cult does not operate like that whilst constantly assuming the same attitude about people like you.**

But doctors are meeting patients all over the world every day and always have. So, have all the 'proof' of claims that you see in this film been either missed or ignored? Sounds like a conspiracy, eh? Eh eh?? Which leads to...

**THE ANTI VAXX INVERSE PROPORTION RULE:** THE LESS PEOPLE HAVE ANY REAL, HAND TO HAND OR PERSONAL INVOLVEMENT IN THE PHARMACEUTICAL INDUSTRY OR GOVERNMENT, THE MORE THEY SEEM TO THINK THEY CAN MAKE JUDGEMENTS SUCH AS 'THERE IS A CONSPIRACY TO HIDE THE TRUTH, MASS BRAIN DAMAGING AND DEATHS FROM VACCINES'.

This actually applies to conspiracy theorists in general I think? The less people have a ticket to the Biederbeck conference, the more they think they know what's going on in it. Also the more they are drawn to being involved. With the anti vaxxers the motive was always autism in the family. Well, what was diagnosed as such and that they consider vaccine damage. In Vaxxed 2 the motive is extended out to medical maladies in general which are quite liberally attributed to the demon needle.

Note how each interview did not need a family or individual case physician present on the camera. Each family did not bring file and reference notes nor an actual doctor to corroborate. I mean why should they, when they could only tell the truth? These were parents, remember? Parents are never wrong. Parents never lie.

**PARENTS ARE NEVER WRONG. PARENTS NEVER LIE.** Wakefield point blank makes the statement. You can find him in the film saying this.

If you are a parent and you have had something happen to you, no medical professional can and should argue with your opinions about your children. No if's or but's. It was hearing lines like this made me write

this piece. It sounded like bad theatre. If you wrote a story like this and filmed it, would you really expect people to take it seriously as a play or a film show? But somehow these people have done that.

### **THE FILMS KEY ELEMENTS:**

- A TOUR BUS which is covered in signatures and the names of people who are supposed to believe in what is going on. Or that vaccines brain damage, physically harm and kill people. Or what? I don't know. But they are supposed to have gotten a lot of people to sign their names on the side. Or a lot of names have been placed on the side. All with a hash sign and a serial number of course, to give them validity as people whose identities have been recorded by the Vaxxed cult and can later be contacted to be proven to have agreed to...etc.

It's not actually explained what is going on here. But a lot of people are supposed to have agreed to have their names written on the side of it. Presumably as proof that so many people know the truth, agree with the film and so on.

That's right. It's one more thing in the film that you are supposed to see and go...oh, okay. Assuming the above explanations. But if you look closely at freeze frames, many people have placed the names of others. Children and family members. The figures are inflated.

- IPHONE INTERVIEWS. The equipment is kept to a minimum. We assume they used one good broadcast quality camera. The sound is always good and you can often see more than one iPhone being used. This we assume is for the real time Persiscope streaming going on. Lighting is good too. They admit to having a full time cameraman who did the coach driving as well.
- INTERVIEWS THAT YOU ARE SUPPOSED TO BELIEVE ARE NEVER STAGED. I go into this. It's a bit obvious from the numbers who are wearing Vaxxed one branded t-shirts and caps that these people are rather biased. Did they get these items before the tour bus turned up, or had them beforehand? We never know.

Just as how these people came to know of the bus and ended up sitting in it being interviewed is not discussed. Some of course are interviewed in their homes (we assume). But one thing is for sure. These people can only be telling the truth. It is never discussed or shown how if at all, they were briefed on what to say before they were recorded. WE WILL NEVER KNOW JUST HOW MUCH WE SEE AND HEAR WAS REHEARSED OR WORKED OUT TO HAPPEN OFF CAMERA, BEFOREHAND.

- A CONSIDERABLE NUMBER OF CHILDREN, SOME OF THEM CLEARLY MENTALLY DISABLED AND NOT IN A POSITION TO GIVE PERMISSION TO APPEAR, ARE FILMED. Simple as that. Always with parents who are all too happy to have them shown. Whether they liked it or not.
- THERE IS NO SUCH THING AS A CONTRARY ARGUMENT. No one gets interviewed or included who has any kind of opposition of any sort to the majority of the interviews. Sorry, all the interviews.
- THE BUS NEVER TURNED UP ANYWHERE TO FIND A PROTEST ON CAMERA. Craig Egen was invisible! Protests like ours were never seen! Did the bus sneak up in secret without promoting its arrival via local media? If so then the people who turned up on it must have been part of an online group awaiting its arrival. See?

**I HAVE A COPY OF THE FILM** and it is frightening. Let us go over the main points of the one hour and 37 minutes they edited down from Periscope steamed interviews and specially made parts. Because primarily V2 was a road trip movie as well as a genre known as 'fan film's'. This on account of how it tries to follow on from and even celebrate the first film, V1.

**PERISCOPE** is a live streaming platform. You can 'like' or say what you think otherwise via the use of emoji's you can use as you watch. So you get this flock of symbols flying up the screen. Psychology has already started to research what these things mean and what effect they are having more and more in people's lives.

**V2 IS BASICALLY A BEST OF COMPLATION OF PERISCOPE STREAMED AND/OR ESPECIALLY FILMED REAL - TIME INTERVIEWS. THAT ALWAYS WENT REALLY WELL FOR THEM.** Well that was interesting wasn't it? All those interviews that did not go wrong. Or did they. Where are the outtakes?.

If every single Periscope encounter went as well as the material you see here... Well don't you see the point? When did any interview break down? When did people confront the tour bus with criticism? When did Tommey etc not have a great interview?

I know for a fact that one man followed the bus around America, protesting it. Craig Egan an Uber driver, followed the bloody thing 7,000 miles during it's 2017 tour. Here he is.

**W**hen anti-vaccine activists gather in the shadow of the big black “Vaxxed” bus, it’s easy to spot the guy who’s there without an invitation.

He’s the protester holding a homemade sign declaring that vaccines save lives. He’s often wearing a T-shirt with the name of the polio vaccine pioneer Jonas Salk, stylized like the logo of a rock band. You might even spot him filming a lighthearted video updating his online followers on his quest to chase down the Vaxxed bus tour, which grew out of a controversial [anti-vaccination documentary](#) with the same name.

Note how it explains that he appears to have tried never to miss an opportunity to get in the way of any camera’s present. Which he fails to do during V2. This from **statnews.com**.

So already we have someone who, as far as the Vaxxed people are concerned, does not exist and cannot be related to. Like all the arguments thrown at them against what they believe. Bubble universe.

The above was written a long time before the great Covid 19 epidemic. When the significance of what the Vaxxed people were doing was to become apparent to far more people than the likes of Craig here and myself.

**IF I CANNOT HAVE YOU THEN NOBODY ELSE WILL.** There is an old cliché around being a spurned lover where they threaten to murder their partner if they won't come back to them. This for me seems very appropriate to quote as summing up a certain attitude that I kept coming across over the years. A faction of the parents of autistic children who campaign for cures and may also believe in it as being brain damage have always manifested these properties:

- **They reject their children's autistic natures.** They call it a disorder, a disability and even a mental illness. The phrase YOU CANNOT DEFINE A CHILDS IDENTITY BY A PSYCHIATRIC DISORDER has been used more than once. Notice the aggressive need to stigmatise coupled with the attempted use of 'appropriate and authoritative' medical terms. Trying to subscribe to science backed frames of reference for authority in what they say. This is always due to the child being mentally incapacitated and visibly dysfunctional, and this being attributable to their NeuroDivergent diagnosis.

This was my point in the IF I CANNOT HAVE YOU...quote. The way they come across as if vengeful towards the world. Showing no capacity to accept that you can have the same condition manifest in different ways other than severe disability – or even defineable as disability. They refute that NeuroDivergency manifests in different way. The only real autism for them, is severe disability. Otherwise, and I have seen this written, they say it is not autism.

- **They act in a very hostile way towards people like myself.** I have come across some very nasty stuff on social media. It's always the same. They start mildly swearing and getting very aggressive, describing their childrens behaviours such as incontinence (leaky arses are nice, eh? That's \*\*\*\*\*ing something to celebrate you say?) biting and assaulting their family and themselves (oh so you want to have autism pride around that?) and their never being able to lead independent lives due to support needs.

This has happened every year I have used the medium since it all started for me. Such people started invading forums for autistic people and sharing stories about their children before Twitter and Facebook took over everything in this world. I recall autistic people complaining at the invasion of their space.

It became apparent that a faction of such people keep appearing who show hatred and aggression against anyone who uses the term autism to mean things they do not like. Some of us think this is due to trauma. Life with their disabled children has affected them so badly that they need someone to lash out and attack over it all.

- **They are prone to also being 'curebies'.** People who want to turn their autistic children **Neurotypical**. It can be described as an industry. There are a lot of people involved, not just parents. Doctors and therapists the world over have always turned up claiming to be able to cure autism. Primarily the world of autism thought was either academic or medical. No one else was interested

in it apart from parents. You got the odd sufferers account which could only turn up in books like *THE MAN WHO MISTOOK HIS WIFE FOR A HAT* by Oliver Sachs etc. Even then that's about disorientation.

- **The advent of self advocating autistics is a whole new thing.** We had to start from scratch and invent our own terminology and perspectives. The kinds of parents I am describing here, did not like that. They still do not. Ultimately any description like this leads to mentioning the biggest and most famous (or infamous) American organisation Autism Speaks. A parent – led charity which has always been taken to have a curing agenda. One of many groups that champion the worst case scenario perspective over the term autism.
- **They support the vaccines cause autism community.** Not all of them do this but I keep seeing such people allying with the Anti Vaxxers. They do not have to believe, merely find kinship with them. But they tend to gang up together in order to have an effect in life. Which leads us to...
- What are they trying to achieve? The diverting of all funding available, and the realisation of as much as they can raise from anywhere, into research that will find the causes and cures of their families NeuroDivergency. The support by any means of their lives with disabled family. Support for the rest of their families lives, including when they are not around.

These are all noble things. Entirely understandable. The faction I am describing seem to behave as if I and my kind personally threaten all these goals. How? Well actually none of us are too sure apart from our diverting attention and funds. The idea of people saying it's okay to be autistic, and demonstrating abilities resulting from our autistic natures and even liking being what we are.... Oh dear. You cannot have that with them.

At this point I have to confess my own problem with the world of disability representation. I have always considered myself to be a grey area when it comes to being definable as disabled. Many autistic people are adamant that having an autism diagnosis must automatically mean you are disabled. Thus you can have as much support as the state/government allows. Which many of us need. But in my own case I keep seeing how my deficits can be defined as simply having a lack of ability rather than disorder/being disabled. I think a lot of us are like that.

But yet again, the arguments against autism as a disorder/disability and for it being a human variance in which these things manifest differently from person to person....ah. Fight after fight sometimes. It is as if people will not listen to reasonable arguments or understand that some issues are not binary. You just cannot have things one or the other. The lack of ability of many people to acknowledge the subtleties of life. Things should be described in gradated ways. Again, this can all be traced back to the curing agenda.

- **So cure it. Then what?** Did you notice how you took a certain frame of reference for granted here? You need to watch that habit. In the world of autism I think you really do need to question all assumptions, every day.

*The magic machine takes an autistic child (ever hear of adults being cured or anyone trying to? Aha...) and they get out of its' huge chamber and go...HEY! I AM OKAY NOW! I FEEL EMPATHY AND WANT FRIENDS....* Or the drugs slowly return them to a state that it is assumed they were initially in before THE AUTISM destroyed them as people. Or week by week they learn to relate and think and feel like NORMAL, CURED people. Then everything will be okay. They will play and learn and grow up and

achieve and everything will be okay. They will have jobs and relationships and interact with their parents and everything will be okay. Simple. Then everyone can forget about evil autism, that sickness that was cured.

Notice anything a bit odd about this paragraph?

One of the projections of the people I am describing is that they get the idea that we do not want people cured of autism. In fact it's got nothing to do with anyone what you do with your children's brains. Further I have no idea how anyone like myself could influence what parents do with and to their kids. But if you go on social media you find these strange, aggressive people, acting in a seemingly paranoid way around folks like me.

Yes that is right. Attacking autistic people and calling us bullies (this happened around criticisms of the infamous All in a Row play that was on the Southwark playhouse. The phrase DON'T LISTEN TO THE BULLIES was used to describe when people objected to the play). Erm...it's called arguing or opposing views. Which seem to be. Okay to do when you agree with curing but not when you do not. Which leads me to my conclusion.

- **Some people in the world of autism debate, want you dead if you argue with them.** This is very typical of the single minded or one pointed mind. Simple as that. Which I think neatly leads us to the rest of the document.
- **They all seem to think they are leading a global societal rebellion.** I get to make this point much later on as an aside on a Tweet that references Adolf Hitler and the Nazi party by Del Bigtree. The constant theme of governments all over the world, apparently without exception, lying to their citizens, manipulating and controlling them without their realising it and generally acting like totalitarian...etc etc. Yeah yeah, like you don't know this one.

So lets have a revolution against the people we all voted into office in the first place, then abolish vaccines. How long would you give the human race to survive? Making them entirely voluntary? Erm, now I might not be an expert but even I can see that it just does not work like that....

I hope this section has given you some insight into what is going on.

Some folks just cannot help but be completely right in their views. I just want to know if I am wrong in mine, rather than asserting them all over the place. I seek to be proven wrong in order to improve my ideas and experience of everything, and to share the results. But I have never, ever seen people in the Wakefield Cult doing that.

I am convinced that if you say anything to these people that sounds remotely like something they would believe, they will.

If you say anything against their beliefs, they are not likely to explore it. Rather they either ignore, go round in circles, say you are a fool and part of a conspiracy whether you know it or not...a number of responses. Other than, oh, right, let me consider that? Thank you, and lets debate.

Which is one major reason I wrote this article as much as why I don't want to finish it.

Parents are never wrong.

Parents never lie.

Parents know best.

Parents have been betrayed.

Parents have been bereaved.

Always believe parents.

## **PART TWO. A REVIEW OF THE FILM.**

### **VAXXED 2 – THE PEOPLE’S TRUTH FILM.**

*There is to my mind, something odd about the overall narrative. The film makers take for granted certain ideas and ways that things are, that I think are fantasies. Ways of seeing the material and interviews that they think cannot be questioned. Connections are assumed between events that do not work like that in reality. It is full of absolute statements which are made throughout without any fear of contradiction.*

I have cherry picked elements of the film because honestly, the pathetic slew of propaganda and biased comments is so dense that it's quite upsetting to have to go through. Besides which there is no point. Talk about bias the movie. But if you want a simple explanation of all this, have a look at the stencilled slogan in this screen shot? The HOORAY is from subtitles of what is being said.

7:50 into the film a couple did this to the newly acquired tour bus that Tommey announces she has just bought. They painted it black and placed these stencils on the side. Note the message?



At no point does anyone talk about any Government conspiracies at all by the way. The concept appears on the side of the bus and thereafter it never gets referred to. This is a major reason why I wrote this commentary. The film appears to be part of a bigger world view that they don't condescend to explain because, I assume, you are meant to be reading up on their social media and websites in order to subscribe to their belief system.

What do they mean by GOVERNMENT PROPERTY? That citizens are forced to be vaccinated and thereafter they are owned by the state, like cattle? That anyone who goes along with mass vaccination is subscribing to some sort of George Orwell 1984 style scenario? What? That they

reject the government of the country all this is happening in (America by the way) and are campaigning that others, if not all of us, rebel against whatever governments our countries have?

Clarification please. Feel free to contact me on social media. It's easy.

**THE FIRST PART OF THE FILM DISCUSSES WHAT HAPPENED WITH THE SCREENINGS OF THE FIRST VAXXED FILM.** In the USA. In Britain the thing was banned. Any screenings were seized upon and actually acted against. The 2016 Vaxxed screening in the Regents part university buildings were conducted in secret and only publicised at the last moment amongst those who were loyal to the cult. Thereafter the College of Homeopath's organisation who were renting the space and allowed the big calibre video projector to be used to show the film, were asked to leave. They had their booking cancelled and do not use that space any more.

To my knowledge, both Vaxxed films only exist on digital format. No cine film was ever used. Without the full resolution technology we can nowadays take for granted this film would not look at all as it does, or circulated as it has. Imagine a VHS video copy being exchanged from hand to hand and bootlegged via two machines in tandem? That is the real identity of these films. Not major chain cinema releases that you can get in the high street on dvd. Both films were for a while available on Amazon Prime to download but got taken off. They can be found on the menu's though, together with the documentary on Wakefield called The Pathological Optimist. As of November 2020 that film is available to rent.

Not cheap any of them. The cash of course goes back to our heroes, bravely trying to save the world by putting us all of the very thing that facilitates strangers to mix and mingle in the first place.

THE SOUNDTRACK SEEMS DESIGNED TO MANIPULATE. A low bass rumble goes on for several moments at the start of the film. This generates an atmosphere. You are being steered and manipulated right from the start. Which funnily enough is what they cult reckon goes on with the media.

#### COUPLE WITH REGRESSED CHILDREN.

All became non verbal and sullen after vaccines. Mother breaks down.

#### LAWYER AND FORMER DISTRICT ATTORNEY. Around 15 minutes in.

Mexican couple deny their child was ever autistic when their son goes into being overtly on the spectrum at 18 months, after a vaccine. Starts referencing '*since someones greed and deception*' and thus the Big Pharma conspiracy. (But does not use that phrase). "*I can tell you for a fact that he was not born on the spectrum of autism*". He goes on to call the term autism in general, injuries. *POP, HOW DO I GET OUT OF HERE...*

HYSTERICAL MUMS CLUB. *My son was born healthy... We were left with the shell that we are still dealing with... My son would have been a football player. Instead he is in diapers. A mother cannot find a doctor who will take my son on.* No specification as to what sort of doctor and why.

A 3<sup>rd</sup> mother appears with an autistic daughter. Then mother after mother comes through on the camera. All telling the same stories of autistic regression. A slew of mothers, some with male partners. The lawyer from the second interview kept appearing during the above stream of mom soundbites as well.

21 minutes in we get image after image of what we assume are autistic children, their eyes rolling. They care clearly meant to be brain injured and pointless rather than people who don't do eye contact and are overwhelmed. OMINOUS MUSIC. (*Watch out for soundtracks in documentaries. What are they trying to do with your feelings*).

21:30 A panorama of all these (often) crying parents appears, and as the camera pans out we get the impression of a riot of suffering. Then it cuts out. We get silence. This is a very aggressive and upsetting few seconds of sequence. Then the couple from the first interview return and say that WHAT IS CONSPICUOUSLY ABSENT IS ANYONE WHO TOLD YOU THOSE SHOTS WERE SAFE IN THE FIRST PLACE. THEY ARE ALL ASLEEP IN THEIR BEDS. This is followed by an animation...



This is clearly a representation of a medical professional/doctor, due to the stethoscope top right. At this point several subtitles appear to reinforce what the parents are saying about their child. The words CONSPICUOUSLY ABSENT appears and fades.

22:30 Tommey explains what she is about....LISTENING TO THE STORIES OF THE PARENTS OF VACCINE INJURY. Images of more autistic children appear. People appear to be wearing Vaxxed t shirts and merchandise a lot.

Then an authoritative woman appears called Hilary Butler who is described as a researcher and author. She describes different stages or gradations of how parents are described and categorised who believe all of this. The idea seems to be to saturation bomb the film with people who reinforce the cults beliefs. She mentions, after a list of 'damages' due to vaccines, a list of how parents are demonised and made out to be crazy.

Then Suzanne Humphreys appears. She is subtitle introduced as an MD. An image of her wearing her graduation gown is shown in the corner as she is interviewed. She graduated in physics, then went on to study Internal Medicine (?) specialising in Nephrology.





Humphreys became Tommey's right hand woman for years, and was banned with Tommey from entering Australia a few years ago. In fact they had bunked in through customs, were caught and then were expelled.<sup>2</sup> The issue of Humphreys' qualifications have been debated for some time. Many saying she is nothing of the sort. Actually what is not mentioned is that she calls herself a **Naturopath**.

***(Another woman who turned up in the foyer of the National Autistic Society with Polly Tommey on two occasions is called Dr. Carol Stott. Around 2005/6 I think it was? I am not sure but A: I did not know who they were and B: I gave them passes to enter the building. I am convinced that Stott and Tommey parted company years ago now. Tommey's gruesome comments about ALL DOCTORS not knowing what they are talking about in my First Guerilla Aspies Podcast suggest that Stott has indeed departed the cult. For further reading on Dr Carol Stott, see Brian Deer's book The Doctor Who Fooled The World where yet again, Brian Deer goes into print with the sort of accusations about Dr Stott's behaviour that, if they were baseless, could bankrupt him).***

This is all 25:20 minutes in. Then appears Wakefield to reinforce the point about medical professionals that he says are unable to come forward to tell their stories? Never named...

Then we get a slew of people claiming to be doctors. Good qualifications too. But so had Wakefield.

Then Wakefield says that what they were led to believe in and through SPONSORED MEDICAL EDUCATION...WAS IN FACT A GRAND LIE.

So just as you think, well this is it. The Pro's will speak. Wakefield comes out with this? Which is rather odd as what he describes is the main thing in his entire life that he personally claimed any authority from. His identity too – the Doctor Andrew Wakefield. Medical degree. Any further

Yet one more anti vaxx bandwagon chaser.

qualifications he pursued were not in gardening or knitting. He only ever studied and did one thing in his life. Medicine.

You then get all these people admitting that during their medical training they were taught *very little* to nothing at all about vaccines. Which is a bit odd considering that reading up on the subject is not illegal or strictly controlled in the USA. There is a phrase in law courts we all know ...DO NOT LEAD THE WITNESS. Well, they all sounded led to me.

Then we get some very odd statements like the woman claiming to have a phd in immunology eulogising how vaccines are always made out to be 100% safe. How could she not know about allergic reactions and when they go wrong. YES THEY DO AND WE ALL KNOW THAT. It's common sense some people will have reactions, sure. Then they recover. (Like all the people who turn up later on explaining what those terrible needles did to them personally. Okay, not that many actually. What they don't discuss is how on Earth they can be there in front of the camera when the general story is that vaccines brain damage, main the brain and even kill. They all sounded pretty compus mentis to me. I personally have an aching upper right forearm where I received the first of my Oxford Covid vaccine trial injections in 2020. Six months later I think that I still feel a mild ache in the muscle involved sometime. Big deal).

All you hear is these people outlining what they were taught in their formal training about vaccination. Which is edited to sound like a whitewashing of the beliefs the Wakefield Cut now has. It's clever. They go around in circles saying what they were told about vaccines and what they were led to believe about vaccines and...that's it.

Then one of these people starts to discuss...what do they put in vaccines?? 28:37 Other doctors start talking about how little they knew about what was in them. Then statements to the effect that they were taught zero about what could go wrong with them. Further odd statements ensue about how you have to research yourself about vaccine side effects and when things go wrong. Then we get *IN VACCINE FIELD, YOU REALLY HAVE TO BE A SELF-TAUGHT EXPERT* from the phd in immunology woman. About 29:50.

This was a bit of a surprise to me, since I personally know more than one person with specialist qualifications in the field. One has post doctoral and the other a Bsc and an Msc. I guess these courses are conducted in secret?

No one notices anything odd in all of this and, like all the narrative so far, it just goes on in the same direction. Then the same reiteration *YOU HAVE TO LISTEN TO THE PARENTS...YOU HAVE TO TRUST THE PARENTS*.

**THEN THE SEQUENCE IS OVER. That's about three minutes and the doctors disappear.**

The one group of people who could make a difference and they are gone. Like I said before, having effectively gone around in circles saying what they were told about vaccines and what they were led to believe about vaccines and...that's it. No greater depth. No shocking revelatory revealments.

But now, read this sequence from the interview with the phd in Immunology and Tommey? (29:30).



**EH? I THOUGHT THEY JUST SAID.... OH NEVER MIND.** As the woman says I'D SAY NO ONE IS AN EXPERT IN VACCINES. ABSOLUTELY NO ONE, BECAUSE..... Tommey interjects in the second frame, lower line. **PARENTS ARE BY THE WAY.**

The phd woman then agrees, frame three top line with a simple **YES** which is inserted as she continues speaking.

Thereafter we get a sequence devoted to film of parents and children witting on the Vaxxed bus, over which Tommey Declares **YOU HAVE TO LISTEN TO THE PARENTS**, and generally saying that the highest medical authority are...parents. That's it. Have children, rule world.

This starts with Tommey declaring **IF DOCTORS DON'T KNOW ABOUT VACCINES BECAUSE THEY HAVE HAD NO TRAINING, THEN WHO ARE YOU GOING TO TRUST.**

The point of confusion is that the people here are referring to when doctors recommend vaccination. Full stop, let alone when it goes wrong. There seemed to me to be this bizarre lack of a simple connection. Doctors – specialists in vaccination and vaccines. See?

What exactly is a PHD in immunology then? Is it illegal for doctors to call on or listen to or read the work and ideas of specialists, or to refer patients to immunology specialists in the USA? I don't know, must be. Well, shame no one knew about this woman with a doctorate, eh?

There is to my mind, something odd about the overall narrative. Things like this turn up all the time, where the film makers take for granted certain conventions that are I think, fantasies.

Cut straight to this image. (59:59).



As usual, 100% belief. 100% commitment to what is being said. 100% emotional behaviour.

Not the tour bus. Note also the double iphone's being used to capture what is clearly a devastating moment of emotion. I'd assume this was Periscoped live at the time. This is followed by the odd image of a few families, then the tour bus driving around with tinkling, moving music. You have to watch the effect of the music in this film.



30:29 we get this clip of around 50 people cheering. The crowd contains Wakefield, Bigtree and Tommey with some faces I think are familiar from interviews. The signs are all clearly uniform with say 3 exceptions – A1 printed by the Vaxxed cult and probably kept on the bus. The clip lasts 30:29-31 seconds. I cannot see Craig Egan anywhere???

Supposing the bus hardly moved anywhere or that the majority of the interviews were in one place. The bus then travelled around, making it look like it included people from across the entire country. Again, it's not clear. Cult members will of course argue that they knew the route and saw the interviews in real time. I assume. I do not know.

But the Periscope account does not include lots of what is in the film. Or did it include more that were not saved for the long term because they were full of doubts and...OH WELL, MAYBE I AM WRONG or...OR WELL, THERE ARE OTHER EXPLANATIONS...being said?

(I think it is fair to say that Wakefield's suit and lab coat wearing days on media and in interviews are over. This gives you a sense of just how much involvement the man really has with the 9-5, regular hours and working under contract world. The home of formal science and medicine. My point would have been better made if it was the 1960's and he had a kaftan on. No matter how much they call him a Doctor, he is not and he's a long way from any formal medicine establishments these days. Yet still – people want to believe him).

We must also consider just how many people were interviewed on the same day or in the same areas. Was this bus tour really a fraud and the people who turned up, merely a staged itinerary rather than 'THEY WANDERED ONTO THE BUS BECAUSE THEY HEARD WE WERE LOCAL, AND MET US FOR THE FIRST TIME. THEN THEY TOLD THEIR DEVESTATING TRUTHS TO OUR CAMERAS...' Which seems to be what is inferred. It's not clear.



The right people are in control says Tommey to this woman, Barbara Loe Fisher. No idea what control or where or how. They just agree on this. NVIC is yet another bogus 'exists on a laptop and website' organisation. It sounds government and mainstream medicine but in fact it's the opposite. So why use a title like that? Why all these attempts at authority.


31:10 A black teenager is shown all the heart likes he is getting on Periscope. His mother speaks off of camera to patronise her darling. He is presumably learning disabled. (Well we are meant to assume I think).

Another scene that just happens.

It's clear from Tommey's references to Periscope platform that when they toured the whole thing was one long real time show, transmitted on there. The Film references this event. You get the

impression that it's been made to sum up the experiences the cult members worldwide had, watching Periscope in real time.

So this is a by and for the fans film.



Then, we get this. The sort of point blanks statement that reality cannot tolerate without everything changing in the media etc. Instead, well, have heard of him?

At this point we appear to be going on about a lot more than just 'autism' and we get increasing amounts of expert medical scientific terminology being used. Which is worrying because A you had better be able to back this thing up and B, just what kind of background knowledge do you need to watch this thing, or more pertinently be part of the cult it is made for?

At 32:40 we get the Colton Barrett story. Del Bigtree appears. Up until now I have been assuming that the main Wakfield cult member on the bus, and one in charge, was Tommey on this bus, but Wakefield and Bigtree keep appearing.

*(Where they travelling to and fro sites? Or where they hiding at the back of the bus, with Bigtree setting up his HighWire show as he went and Wakefield doing whatever he thought he was? More likely they just travelled to and fro I would say. But the point of this question is just how much did they figure in getting people to do the interviews? One thing that become clear is that however many people are involved in the production and administration of the top of the cult, only the 3 main 'talking heads' get the limelight.*

*The titles at the end give you a good idea of the size of the core crew. Now this is interesting on account of people like Tommey's now grown, Neurotypical children being involved. They really wanted to make those titles look like a big deal. How many folks were hired and were actually nothing to do with the cult, I cannot tell).*

Colton Barrett is not actually directly medically attributed to a vaccine reaction. You have to listen to this part really clearly over and over to get that. His mother explained **I STILL LIKE OUR DOCTOR. HE WILL NOT GIVE THE HPV VACCINE TO BOYS ANY MORE BUT HE STILL GIVES IT TO GIRLS. HE'S CAUTIONING ON GIRLS....** That is the full extent of any admission that Colton's sudden semi all over paralysis was caused by the HPV vaccine he received, several days before he was stricken. In fact it's not stated what happened to him at all. One must assume the Periscope people and the Cult's website have gone into that. Have a look?

I don't know about you, but the above makes no sense to me at all if we believe the HPV vaccine did this to Colton Barrett. Sadly Barrett later died. I have no idea and saw no clarification what the term **He's cautioning girls** meant. Presumably he was saying...OH NOW THIS HPV VACCINE SHOULD BE SAFE FOR FEMALES BUT YOU NEVER KNOW, IT MIGHT PARALYSE AND LATER KILL YOU. SO, STILL FANCY IT? Don't ask me.

After Colton we go into a sea of interviews with teenagers and their permanently present, doting parents. In each case I have to assume that definite connective proof and statements were made ELSEWHERE such as on Periscope interviews or on line. Because all you get is testament after testament which INFERR a connection between the Gardasil vaccine and them all losing their mojo's as it were. They were all, we assume victims of this vaccination.

We also come to understand that many of them lost their intellectual abilities as much as their coordination in say dance and sports. Some very odd statements are being made that the viewer appears meant to calmly take onboard and appreciate. One has her mother explain that prior the vaccination she used to have A CLUTCH OF FRIENDS. Then that the vaccination DESTROYED THIS FOR HER.

At this point I want to comment on the rather odd, 'GOES WITHOUT SAYING' nature of the narrative. I kept hearing things that were...you know...bit obvious isn't it...nature. I thought it was due to the film avoiding being sued, banned etc due to making attacks on it's subjects. Instead its one inference after another.

You have to be smart enough to work it out. Or more likely, your faith must guide you to the one true way.

38:55 one of the cult's core priests appears as usual. Suzanne Humphreys discusses the DEVESTATION that Gardasil has apparently caused, followed by Brian Hooker. Again. Then after a doctor interviewed on the tour bus it's Robert F Kennedy, ex heroin addict and environmental lawyer's turn.

During his point blank statements about how the HTP shot will kill all of young female humanity, we read this.



This response from a female friend online:

Working as a cytoscreeener for 20 years there has definitely been a change in the amount of young women presenting with cell changes, which can result in cervical cancer. When I first started working screening, looking at young women's smears I would have estimated about half would have had cellular changes, which left untreated may have resulted in cervical cancer within 10 years.

Abnormalities in young women in younger women attending for smears is now significantly lower. I hear this has also had an impact on oropharynx cancer (throat) , with less people diagnosed with the type caused by HPV, especially now the HPV vaccine is also offered to boys. The hpv vaccine is basically a cancer prevention, not only for cervical cancer, but also oropharynx cancer, anal, vagina and vulva cancer. With an added bonus, it also helps prevent genital warts.

Mr Kennedy was clearly never a woman. Ever. Pre emption is everything with cancer. The sooner you get to it, or in this case head it off altogether, the better. Cancer appears to be beyond the understanding of anyone involved in Vaxxed 2.

Yet on and on they go, until Kennedy makes the statement that the death rates in the Gardasil trials were THIRTY - SEVEN TIMES THE DEATH RATES FOR CERVICAL CANCER. Okay so what am I missing here? Presumably I do not have all the facts. He establishes that there are death rates for cancer, but that females are better off not getting the vaccines and being 37 times less likely to die per se. Or that you may well die of cervical cancer anyhow but at least you didn't die from a vaccination years before? Or lose your abilities. In ways I fail to see any objective quantification apart from the heresay of the families involved.

Exactly. You are not supposed to think that deeply about all of this. Faith is all.

Faith in specific 'research' that only deepens your faith in the mindset you used to find the research in the first place.

Stories abound (42 minutes plus) of females getting Gardasil and then physically suffering, passing out, etc. Then a male appears who never regained his ability (43:30) to fully walk. Hang on, what happened to Gardasil? I don't know, he just appears and then it goes back to the Gardasil bloodbath – a thing that is never disputed or medically proven with documentation or testimonies of the attending doctors. You just get these people, half of them on the tour bus and the rest we assume at home, telling you what is what. Who needs proof?

47:30 we start to get horrifying tales of inner body masses that may become cancerous. Growths deep within. Very dramatic statements. Then we get this...





Erm.....as a lawyer we assume he knows what he is doing with US English? So here he admits that what he is certain is true, cannot actually be proven.

Then later we get..(49:47).



Insanely dangerous? Right. So you can prove that can you? Because if that were the case I find it impossible to believe anyone would get the vaccination. But not Robert F Kennedy.

At this point I yet again have to draw your attention to the mindset involved. There are no doubts or maybe's involved in the world of the Wakefield Cult. Only absolute certainty. No one has to worry about what they say in films, either.

At 49:52 we then get the start of the **PARENT PITY PORN** that I was describing in my sign at the Vaxxed 2 showing in London. Because we receive a graphic description of how a mother felt when she found her daughter dead. In bed at home. It is implied that it was due to the vaccination in question.

Tommey is seen on camera hugging the woman and comforting her as she cries.

Then another mother appears, speaking with dignity of the loss of her daughter as well. Who was in university at the time. Then you get this:



**Please recall the sign you see me holding at the start of the document? Parent Snuff Porn. This is the snuff aspect. We see on the screen an intimate picture whilst we hear her mothers testimony. Her mouth shows foam. Her skin shows rashes and discolouration. This is the dead body of her daughter. Apparently photographed where she died.**

The music is sombre and moody. Violins and plaintiff piano. Designed to steer your feelings in the right direction.


**At this point I want to stop writing this piece because I swear this is the most blatant and awful manipulation and use of tragedy I can think of. What kind of people with use a one in a million event like this to try and convince audiences that it goes on all the time? That what is medically proven to be a life saving, pre - empting cancer vaccine could do this to a young woman? Could do this to you.**

**Now, note the way I think and see things? Consider your own reactions to me. Are you feeling any kind of negative reactions to my statements?** One thing that is clearly central to the entire film is the cold – blooded manipulation of the audiences emotions. If any of this were substantial in it's claims and concerns, are you seriously telling me it would be so ignored?

**Is this film some sort of tear – jerker tragedy, meant to make the audience hysterical?** What you have here is an alternative universe account of reality. It's a different planet. One on which you can have a film making such statements. Inferring that a cervical cancer vaccine could kill ALL young females who go near it. You have to be objective. You also have to wonder, just why this constant emotional theme?

I am part of this whole thing. There are plenty of vaccinations that could kill someone like myself, sure. I take them anyway. I have put myself into the Oxford Covid 19 vaccine trials and receive my second injection in a weeks time. (This is currently the week starting 19<sup>th</sup> October 2020 as I write). That will be the third vaccination injection of the year and I look forward to an influenza injection two weeks or more after that one.

In this case the girl had an infected toe. I don't know how many times a doctor has prescribed antibiotics to you and yours, but everyone I saw appears to be referring to family who can easily be explained as having avoided illness of all kinds. A lot of people do. It does not substantiate the claim that it's due to them not being vaccinated. More like if you take a tour bus through America, which of course is a huge continent, you meet people who have hidden in relatively isolated environments. Also the ones that did discuss travelling...were lucky. Because vaccine herd immunity is everywhere and all humanity washes hands and avoids coughing and sneezing others. It's not hard to stay healthy. It is also it seems, not hard to attribute it all to simply not being vaccinated.

## Global influenza surveillance and virus sharing



Over the past half century a global system, the [Global Influenza Surveillance Network \(GISN\)](#)<sup>1</sup> has grown up under WHO. Through GISN virological and epidemiological surveillance for human influenza is undertaken internationally. This is vital for maintaining global and local health protection against seasonal, pandemic and avian influenza. It would for example be part of the process of detection of a novel human influenza and the next influenza pandemic and it is the way the antiviral resistance was detected in [Europe in 2008](#)<sup>2</sup>. It is one of the tools which the [International Health Regulations](#)<sup>3</sup> would use in an emergency using function Key to the surveillance of viruses are a limited number of high level [WHO Collaborating Centres and Reference Laboratories](#)<sup>4</sup> involved in annual influenza vaccine composition recommendations and many more national influenza laboratories ([National Influenza Centres](#))<sup>5</sup>. In Europe the [Collaborating Centre](#)<sup>6</sup> and the Regulatory Laboratory - the [National Institute for Biological Standards and Control](#)<sup>7</sup> are in the UK. They are supported by the virtual Community Network Reference Laboratory which works under contract from ECDC following an open competitive tender. The [European Commission](#)<sup>8</sup> also supports the process for example through providing underpinning legal regulations in Europe and funding research under the [Framework and public health Programmes](#)<sup>9</sup>. While the [European Medicines Agency](#)<sup>10</sup> also provides an important regulatory role in preparing for the production of human avian influenza vaccines and specific pandemic vaccines ahead of a pandemic.

Jenny's faith in the woosters is unconquerable because they give her what she wants - comfort, an ego boost, simple on-off truths, certainty... and she is very happy to assure you that any and all fake facts you provide to her are just falsified propaganda lies created by Big Pharma or somesuch evil global cabal to make us sick so they get more money. But sure, by all means keep feeding logic and facts to her. You never know, maybe she will crack. Maybe she is the one in a million whose faith in her puppet masters can be severed.

A reply to a dialogue on Facebook I was involved in. I actually have nothing but respect for the Jenny involved despite her views. I just wanted to post this wonderful example of one woman's perspective on a genre of people that seem to be the backbone of the Wakefield cult.

**THE ONLINE ETHOS** of reality has everything to do with the cult's activities. In fact I would go as far as to say that without daily activity via public and private messaging and posting, the cult would not have become what it is today. The fact that this medium is limited, edits communication whilst looking like it facilitates it and can easily and effortlessly be used to put over whatever version of reality you want, seems lost on cult members AS FAR AS SEEING THINGS THEIR OWN WAY goes.

**THEY STILL SEEM TO THINK THESE FILMS ARE UNIMPEACHABLE.** If you refer to my previous piece on Vaxxed One, it seems to me that no matter what has been said to them all, the narrative of the first film remains without any need to be edited, qualified or improved upon.

**PARENT SNUFF PORN.** At the start of this document you will see the author himself clutching a sign. It was one I thought about and did not simply produce for shock value. Whatever feedback I have seen/intercepted from Cult members, leads me to believe they did not understand what I was trying to do, let alone say

directly. The snuff reference is covered in a previous section here. Porn is used loosely, although this entire film is about the body and it's intimate relationship with things put in it (vaccines). So the term is a slang rather than a solid use of English sure. But it had shock value and I am certain that it's valid in an adapted sense. Which is after all the cornerstone of how English was evolved to be used in the culture of the United States of America?

**THEY THINK THIS FILM CHANGES EVERYTHING...AGAIN.** The general ethos amongst the cult members is that the 2016 film 'changed everything'. Four years on I am still waiting to find out what. This one reduced cult members to tears. I have intercepted them on their private forums (hehehe) comparing notes on which point in the film they lose it and have hysterics.

I was attacked by several cult members over my Twitter comments about protesting the event. I told them they were being pathetic and childish when they used the cheap line THANK YOU FOR THE FREE PUBLICITY. Because, of course, they think it can only be seen the way they see it. He he. Not so...

In my previous V1 write up the idea that **THEY THINK THE FILM CAN ONLY BE SEEN THE WAY THEY DO, AND NO OTHER** got it's own heading. Here it's a sub note to the above. Because it's been over 4 years since April fools day 2016 when they 'released' the thing. (The concept of premier and release dates is a bit passe these days due to online, don't you think?) Of course they were using the term to try and push the novelty of the thing being new and this is the first time and here it is etc etc. Bright lights, Grumann's Chinese theatre in Hollywood premier, dreams of it actually being a mainstream motion picture like The Sound of Music, The Terminator or whatever your idea of a big deal when it came out, was. Star Wars films?

Ever hear of a documentary getting the attention that drama's do? The Inconvenient Truth film that Al Gore made did that, as with SuperSize Me. Michael Moore of course has been very successful in this field.

These are examples of documentary films that ARE FACTUAL AND EXPECT YOU TO LIVE IN REALITY. This film thinks it presents more reality than governments, mass media and opposing documentary makers are letting people see. Which ties into its 'persecuted, underground resistance to the giant oppressors/Evil Empire' ethos.

(Has anyone made a counter documentary style film? Well, THE PATHOLOGICAL OPTIMIST gets a heading here because the Cult members really did not like it. A woman made a 5 - year fly on the wall film on the life and times of Wakefield in the USA. He came out of it looking sallow and depressed, haemorrhage money too. I saw it all. Scene after scene of his wife Carmella sticking by and up for her husband and father of her four children. Only a few years later, he left her. Cult members said it did not cast him in a good light. Not like the occasional appearances he makes in both films. In V1 he's interviewed in his home, or someones. In V2 he does that and pops up around the Vaxxed tour buses locations. Does he have wings? Did he follow the thing around? Does anyone know.

A lot of the film was made by one or two cult members who specialise in film. (One particular man drove the bus and worked full time on media production. His name is XXXXX and is a fine example of someone inducted into the Cult without any family connections that have been publicised. Like Del Bigtree). That and iphones using Periscope. Guerilla film making! How romantic and David verses Goliath. Thus we get to negate the reality that if any of this were real, they would not have ever needed to make the film or the trip

across America. The brave freedom fighters are still at war against the evil oppressors (See the comments the two V1 Americans made to the Irish men in pubs they met. Evil Pharma?)

I suspect they are going to be 'at war' for a very long time...

My point here is that there is always a positive ethos you can galvanise to push any old filmed content anyone produces. In this point, it could be actual biological warfare propaganda against the entire planet that relates to the culture depicted in it. Which is the USA. If the majority actually took a look and passed judgement, Cult members may find themselves so challenged in their faith that it would ruin the lives they have build around it all. **JUST HOW MUCH HAVE VAXXED CULT MEMBERS BUILT THEIR LIVES AROUND THE BELIEFS?** Well from what I can see, being intellectual snobs they assume they have a life balance in which their faith, overridingly serious, is one element in the greater job/relationship/family/general life picture. In the case of our friend Charisse Burchett, things are rather biased towards obsessional 24/7 behaviour. How many of them eat, sleep and live the Vaxxed Wakefield Cult?

Del Bigtree has his Highwire YouTube show. Polly roames the world doing what she does, feeding on any local support that is going. Wakefield of course has some money and is able to sit back, Mr Big, and make gracious appearances. Others that don't get the spotlight nonetheless have influence and try to co ordinate locally. Although by now you will be wondering what I am talking about. Co ordinate what? Influence whom? Do what off the internet?

Good question. Like what on Earth these people have to show for all these years of activity apart from trying to stop other people protecting their children and in some cases themselves, from disease.

- **THE EARTH BEING FLAT.**
- **5G MOBILE INTERNET BROADBAND FORMAT BEING A MEANS OF REMOTELY CONTROLLING PEOPLE.**
- **5G MOBILE USING THE METALS SMUGGLED INTO PEOPLE IN VACCINES TO TRACK AND MONITOR YOU..** Because we are all so significant and important in life.

**THE INTERNAL POLITICS OF THE WAKEFIELD CULT.** Where oh where did Dr. Carol Stott go? Not a medical doctor, but still. This was covered in a previous section. Apparently one cult member was betraying them to Brian Deer all along. Their identity is a secret to this day. But you get the idea. What has gone on in their ranks we may never know.





Autistic advocates mass infiltrated it when it went on line due to the sort of epidemic it appears to be trying to encourage, forcing them to. Some grim and bizarre tales of obsessional and delusional ideas were found to be discussed. *(I am capable to going into that, but I wanted to skim over. However if you want the truth you just need to look for the reports of **Autism One critics and autistic advocates** who attended online).*

As usual in this world, note the use of language? CHILDREN WITH AUTISM DO GET BETTER! (What exactly does that mean we wonder?) YEARS AHEAD OF OTHER CONFERENCES. (As usual in this world of theirs, intellectual snobbery appears. Quite a claim, eh?). PARENT FOUNDED, PARENT DRIVEN.. ACHIEVE IMPROVEMENT AND RECOVERY. It's all there in nothing more than an introductory piece tucked away in their website.

The claim that it is the largest and most comprehensive annual autism conference in the world, is easily refuted. Check the Annual European Autism Conference for a start, which I attended the eleventh of in Edinburgh some years ago. I even sold my books there. I can assure that there was ZERO presence of any of the exhibitors or speakers you get in the Autism One conference. I wonder why?

Part of the world of the Vaxxed Cult is this seventeen year old event. Described by those I trust as 'the ultimate quackfest', it brings together the most dubious and medically outlaw people possible to speak on the subject of autism. As if it were a medical illness that sickens children and should and can be cured. In order to restore said children – yes it is all about children – back to the normal states they should have been in, in the first place. In fact in many cases they are all assumed to have been in a so called normal state of being before they were diagnosed autistic. However the term is used.

You need to know that a simple investigation of the speakers over the year shows that several different accounts of what being autistic means usually turn up in the event at the same time. 

A group of British anti-maskers behaved 'like spoiled brats' when they refused to wear face coverings on a flight home from Berlin, a source claimed today.

Charisse Burchett was criticised on Wednesday after she shared an image of herself and two women seated on an aircraft having apparently won a 'stand off' with airport staff.

The women were flying with [British Airways](#) from [Berlin](#) back to [London](#) Heathrow Airport following an anti-lockdown meeting, but refused to wear face masks as they allegedly have a medical exemption.

An insider, who claimed they were on the flight, told MailOnline the group began 'coughing as a joke' after eventually boarding the plane, but said 'this seemed very fake and put on.'

The source added the 'ring leader' had behaved 'like a spoiled brat' throughout the confrontation with airport staff - 'marching up and down the departure gate and shouting.'

They added: 'They were universally condemned by all other passengers in the airport.'


'I talked to a very nice young man who genuinely had a medical exemption but felt "it's because of people like that I just wear a mask and try and get on with it".

'The German police and security acted professionally at all times trying to find out why they wouldn't wear their masks.

'The police only arrived when they were getting irate with the airport staff who wanted to see their doctors note for the "medical exemption" which is the rule in Germany.'

The insider added they don't know why the women were eventually permitted to board the plane.

Ms Burchett claimed in a tweet that the group all 'had medical exemptions' which allowed them to go without masks on the flight.

Sharing an image of the group on Wednesday, she wrote: 'We had a ten Brit mask-less standoff at Berlin airport.'

'Police and authorities could not make us wear masks. Our last protest on German soil. I love this cheeky photo.'

She later added: 'It was a standoff and I have a film to prove it. The Nazi police and airport officials were incredibly intimidating.'

'You need to think about where this is heading and it's not good.'

Ms Burchett went on to claim the women all 'had medical exemptions.'

She said: 'We had medical exemptions. But passengers can take theirs off to eat and drink? So the virus is not that deadly on a plane is it really? It's about being compliant.'

Another user Amanda Brooks tweeted: 'Clearly, education, manners and respect (including self respect) are qualities you do not have. Your families must be embarrassed.'

However, some defended Ms Burchett's right not to wear a mask.

It comes as German Chancellor Angela Merkel warned Germany is heading for 'disaster' after regional leaders refused to sign off on her tough new coronavirus measures amid surging cases in Europe.

Several German cities, including financial hub Frankfurt, have imposed a curfew on bars and restaurants, 10-person limits and compulsory use of masks in busy areas.

But today, a Berlin court suspended the curfew on bars and restaurants, joining other courts in overturning government-imposed measures meant to contain the further spread of the coronavirus.


Germany, like other countries across Europe, is dealing with a sharp rise in coronavirus infections.

That was the end of her communications. Apart from the WE ARE PUTTING YOU IN AN EXHIBITION comment. Within two months Covid 19 became rampant and the entire planet was discovering what happens when you have a virus outbreak that dangerous that no one can control. Well, all except Wakefield/Vaxxed cult members by the looks of it.

There was another attempt to contact me by cult members, which appeared to be a vague attempt at intimidation. But I won't even bother to post it unless the man returns online.

As far as my friends and I can tell, Burchett is regarded as a perfectly reasonable and respectable member of the cults group. The Emma being referred to is my friend Emma Dalmayne, CEO of the Autistic Inclusive Meets charity and a single mother of six autistic children. She has featured on the BBC, in the Times and Guardian newspapers and is a unique advocate for autistics and a campaigner against the abuse via 'treatments' and 'cures' of autistic children. Please look her up. She has accomplished a unique and history making body of work.

Herself autistic, Emma was brave enough to bring twelve of us autistics together to stand outside and generally find the whole thing funny. We had some conversations with one or two people which were very interesting. But no one changed our minds. Now, they could have. But our amicable encounters just did not do that.

**IT ALL STARTED HAPPENING IN REAL TIME.** As much as I tried to avoid being sucked into this business to any greater extent, it became impossible to write this piece without updating it and including events that appear to directly proceed from it in real time. The pandemic of 2020 was not something the Vaxxed cult ignored. They decided they were going to try and stigmatise the much needed vaccines to stop it. All the while posting on line and speaking as if they had an untouchable authority to do so. Which was very strange because I do not know where it goes with the laws of the different countries of the world, when you try to turn people off a vaccination that could stop a dangerous and in many cases lethal pandemic. I have undermined this because I really would like to know.

During the pandemic of 2020, Tommey and Bigtree starting posting on social media. Where else can they be found or heard?

***Applies Only to Petitions for Compensation Filed under the National Vaccine Injury Compensation Program on or after March 21, 2017***

(a) In accordance with section 312(b) of the National Childhood Vaccine Injury Act of 1986, title III of Public Law 99-660, 100 Stat. 3779 (42 U.S.C. 300aa-1 note) and section 2114(c) of the Public Health Service Act, as amended (PHS Act) (42 U.S.C. 300aa-14(c)), the following is a table of vaccines, the injuries, disabilities, illnesses, conditions, and deaths resulting from the administration of such vaccines, and the time period in which the first symptom or manifestation of onset or of the significant aggravation of such injuries, disabilities, illnesses, conditions, and deaths is to occur after vaccine administration for purposes of receiving compensation under the Program. Paragraph (b) of this section sets forth additional provisions that are not separately listed in this Table but that constitute part of it. Paragraph (c) of this section sets forth the qualifications and aids to interpretation for the terms used in the Table. Conditions and injuries that do not meet the terms of the qualifications and aids to interpretation are not within the Table. Paragraph (d) of this section sets forth a glossary of terms used in paragraph (c).

(b) *Provisions that apply to all conditions listed.* (1) Any acute complication or sequela, including death, of the illness, disability, injury, or condition listed in paragraph (a) of this section (and defined in paragraphs (c) and (d) of this section) qualifies as a Table injury under paragraph (a) except when the definition in paragraph (c) requires exclusion.

(2) In determining whether or not an injury is a condition set forth in paragraph (a) of this section, the Court shall consider the entire medical record.

(3) An idiopathic condition that meets the definition of an illness, disability, injury, or condition set forth in paragraph (c) of this section shall be considered to be a condition set forth in paragraph (a) of this section.

(c) *Qualifications and aids to interpretation.* The following qualifications and aids to interpretation shall apply to, define and describe the scope of, and be read in conjunction with paragraphs (a), (b), and (d) of this section:

(1) *Anaphylaxis.* Anaphylaxis is an acute, severe, and potentially lethal systemic reaction that occurs as a single discrete event with simultaneous involvement of two or more organ systems. Most cases resolve without sequela. Signs and symptoms begin minutes to a few hours after exposure. Death, if it occurs, usually results from airway obstruction caused by laryngeal edema or bronchospasm and may be associated with cardiovascular collapse. Other significant clinical signs and symptoms may include the following: Cyanosis, hypotension, bradycardia, tachycardia, arrhythmia, edema of the pharynx and/or trachea and/or larynx with stridor and dyspnea. There are no specific pathological findings to confirm a diagnosis of anaphylaxis.

(2) *Encephalopathy.* A vaccine recipient shall be considered to have suffered an encephalopathy if an injury meeting the description below of an acute encephalopathy occurs within the applicable time period and results in a chronic encephalopathy, as described in paragraph (d) of this section.

(i) *Acute encephalopathy.* (A) For children less than 18 months of age who present:

(1) Without a seizure, an acute encephalopathy is indicated by a significantly decreased level of

consciousness that lasts at least 24 hours.

(2) Following a seizure, an acute encephalopathy is demonstrated by a significantly decreased level of consciousness that lasts at least 24 hours and cannot be attributed to a postictal state—from a seizure or a medication.

(B) For adults and children 18 months of age or older, an acute encephalopathy is one that persists at least 24 hours and is characterized by at least two of the following:

(1) A significant change in mental status that is not medication related (such as a confusional state, delirium, or psychosis);

(2) A significantly decreased level of consciousness which is independent of a seizure and cannot be attributed to the effects of medication; and

(3) A seizure associated with loss of consciousness.

(C) The following clinical features in themselves do not demonstrate an acute encephalopathy or a significant change in either mental status or level of consciousness: Sleepiness, irritability (fussiness), high-pitched and unusual screaming, poor feeding, persistent inconsolable crying, bulging fontanelle, or symptoms of dementia.

(D) Seizures in themselves are not sufficient to constitute a diagnosis of encephalopathy and in the absence of other evidence of an acute encephalopathy seizures shall not be viewed as the first symptom or manifestation of an acute encephalopathy.

(ii) *Exclusionary criteria for encephalopathy.* Regardless of whether or not the specific cause of the underlying condition, systemic disease, or acute event (including an infectious organism) is known, an encephalopathy shall not be considered to be a condition set forth in the Table if it is shown that the encephalopathy was caused by:

(A) An underlying condition or systemic disease shown to be unrelated to the vaccine (such as malignancy, structural lesion, psychiatric illness, dementia, genetic disorder, prenatal or perinatal central nervous system (CNS) injury); or

(B) An acute event shown to be unrelated to the vaccine such as a head trauma, stroke, transient ischemic attack, complicated migraine, drug use (illicit or prescribed) or an infectious disease.

(3) *Encephalitis.* A vaccine recipient shall be considered to have suffered encephalitis if an injury meeting the description below of acute encephalitis occurs within the applicable time period and results in a chronic encephalopathy, as described in paragraph (d) of this section.

(i) *Acute encephalitis.* Encephalitis is indicated by evidence of neurologic dysfunction, as described in paragraph (c)(3)(i)(A) of this section, plus evidence of an inflammatory process in the brain, as described in paragraph (c)(3)(i)(B) of this section.

(A) Evidence of neurologic dysfunction consists of either:

(1) One of the following neurologic findings referable to the CNS: Focal cortical signs (such as aphasia, alexia, agraphia, cortical blindness); cranial nerve abnormalities; visual field defects; abnormal presence of primitive reflexes (such as Babinski's sign or sucking reflex); or cerebellar dysfunction (such as ataxia, dysmetria, or nystagmus); or

(2) An acute encephalopathy as set forth in paragraph (c)(2)(i) of this section.

(B) Evidence of an inflammatory process in the brain (central nervous system or CNS inflammation) must include cerebrospinal fluid (CSF) pleocytosis (>5 white blood cells (WBC)/mm<sup>3</sup> in children >2 months of age and adults; >15 WBC/mm<sup>3</sup> in children <2 months of age); or at least two of the following:

- (1) Fever (temperature  $\geq 100.4$  degrees Fahrenheit);
- (2) Electroencephalogram findings consistent with encephalitis, such as diffuse or multifocal

nonspecific background slowing and periodic discharges; or

(3) Neuroimaging findings consistent with encephalitis, which include, but are not limited to brain/spine magnetic resonance imaging (MRI) displaying diffuse or multifocal areas of hyperintense signal on T2-weighted, diffusion-weighted image, or fluid-attenuation inversion recovery sequences.

(ii) *Exclusionary criteria for encephalitis.* Regardless of whether or not the specific cause of the underlying condition, systemic disease, or acute event (including an infectious organism) is known, encephalitis shall not be considered to be a condition set forth in the Table if it is shown that the encephalitis was caused by:

- (A) An underlying malignancy that led to a paraneoplastic encephalitis;
- (B) An infectious disease associated with encephalitis, including a bacterial, parasitic, fungal or viral illness (such as herpes viruses, adenovirus, enterovirus, West Nile Virus, or human immunodeficiency virus), which may be demonstrated by clinical signs and symptoms and need not be confirmed by culture or serologic testing; or
- (C) Acute disseminated encephalomyelitis (ADEM). Although early ADEM may have laboratory and clinical characteristics similar to acute encephalitis, findings on MRI are distinct with ADEM displaying evidence of acute demyelination (scattered, focal, or multifocal areas of inflammation and demyelination within cerebral subcortical and deep cortical white matter; gray matter involvement may also be seen but is a minor component); or
- (D) Other conditions or abnormalities that would explain the vaccine recipient's symptoms.

(4) *Intussusception.* (i) For purposes of paragraph (a) of this section, intussusception means the invagination of a segment of intestine into the next segment of intestine, resulting in bowel obstruction, diminished arterial blood supply, and blockage of the venous blood flow. This is characterized by a sudden onset of abdominal pain that may be manifested by anguished crying, irritability, vomiting, abdominal swelling, and/or passing of stools mixed with blood and mucus.

(ii) For purposes of paragraph (a) of this section, the following shall not be considered to be a Table intussusception:

- (A) Onset that occurs with or after the third dose of a vaccine containing rotavirus;
- (B) Onset within 14 days after an infectious disease associated with intussusception, including viral disease (such as those secondary to non-enteric or enteric adenovirus, or other enteric viruses such as Enterovirus), enteric bacteria (such as *Campylobacter jejuni*), or enteric parasites (such as *Ascaris lumbricoides*), which may be demonstrated by clinical signs and symptoms and need not be confirmed by culture or serologic testing;
- (C) Onset in a person with a preexisting condition identified as the lead point for intussusception such as intestinal masses and cystic structures (such as polyps, tumors, Meckel's diverticulum, lymphoma, or duplication cysts);
- (D) Onset in a person with abnormalities of the bowel, including congenital anatomic abnormalities, anatomic changes after abdominal surgery, and other anatomic bowel abnormalities caused by mucosal

hemorrhage, trauma, or abnormal intestinal blood vessels (such as Henoch Schölein purpura, hematoma, or hemangioma); or

(E) Onset in a person with underlying conditions or systemic diseases associated with intussusception (such as cystic fibrosis, celiac disease, or Kawasaki disease).

(5) *Chronic arthritis.* Chronic arthritis is defined as persistent joint swelling with at least two additional manifestations of warmth, tenderness, pain with movement, or limited range of motion, lasting for at least 6 months.

(i) Chronic arthritis may be found in a person with no history in the 3 years prior to vaccination of arthropathy (joint disease) on the basis of:

(A) Medical documentation recorded within 30 days after the onset of objective signs of acute arthritis (joint swelling) that occurred between 7 and 42 days after a rubella vaccination; and

(B) Medical documentation (recorded within 3 years after the onset of acute arthritis) of the persistence of objective signs of intermittent or continuous arthritis for more than 6 months following vaccination; and

(C) Medical documentation of an antibody response to the rubella virus.

(ii) The following shall not be considered as chronic arthritis: Musculoskeletal disorders such as diffuse connective tissue diseases (including but not limited to rheumatoid arthritis, juvenile idiopathic arthritis, systemic lupus erythematosus, systemic sclerosis, mixed connective tissue disease, polymyositis/dermatomyositis, fibromyalgia, necrotizing vasculitis and vasculopathies and Sjogren's Syndrome), degenerative joint disease, infectious agents other than rubella (whether by direct invasion or as an immune reaction), metabolic and endocrine diseases, trauma, neoplasms, neuropathic disorders, bone and cartilage disorders, and arthritis associated with ankylosing spondylitis, psoriasis, inflammatory bowel disease, Reiter's Syndrome, blood disorders, or arthralgia (joint pain), or joint stiffness without swelling.

(6) *Brachial neuritis*. This term is defined as dysfunction limited to the upper extremity nerve plexus (*i.e.*, its trunks, divisions, or cords). A deep, steady, often severe aching pain in the shoulder and upper arm usually heralds onset of the condition. The pain is typically followed in days or weeks by weakness in the affected upper extremity muscle groups. Sensory loss may accompany the motor deficits, but is generally a less notable clinical feature. Atrophy of the affected muscles may occur. The neuritis, or plexopathy, may be present on the same side or on the side opposite the injection. It is sometimes bilateral, affecting both upper extremities. A vaccine recipient shall be considered to have suffered brachial neuritis as a Table injury if such recipient manifests all of the following:

(i) Pain in the affected arm and shoulder is a presenting symptom and occurs within the specified time-frame;

(ii) Weakness;

(A) Clinical diagnosis in the absence of nerve conduction and electromyographic studies requires weakness in muscles supplied by more than one peripheral nerve.

(B) Nerve conduction studies (NCS) and electromyographic (EMG) studies localizing the injury to the brachial plexus are required before the diagnosis can be made if weakness is limited to muscles supplied by a single peripheral nerve.

(iii) Motor, sensory, and reflex findings on physical examination and the results of NCS and EMG studies, if performed, must be consistent in confirming that dysfunction is attributable to the brachial plexus; and

(iv) No other condition or abnormality is present that would explain the vaccine recipient's symptoms.

(7) *Thrombocytopenic purpura*. This term is defined by the presence of clinical manifestations, such as petechiae, significant bruising, or spontaneous bleeding, and by a serum platelet count less than 50,000/mm<sup>3</sup> with normal red and white blood cell indices. Thrombocytopenic purpura does not include cases of thrombocytopenia associated with other causes such as hypersplenism, autoimmune disorders (including alloantibodies from previous transfusions) myelodysplasias, lymphoproliferative disorders, congenital thrombocytopenia or hemolytic uremic syndrome. Thrombocytopenic purpura does not include cases of immune (formerly called idiopathic) thrombocytopenic purpura that are mediated, for example, by viral or fungal infections, toxins or drugs. Thrombocytopenic purpura does not include cases of thrombocytopenia associated with disseminated intravascular coagulation, as observed with bacterial and viral infections. Viral infections include, for example, those infections secondary to Epstein Barr virus, cytomegalovirus, hepatitis A and B, human immunodeficiency virus, adenovirus, and dengue virus. An antecedent viral infection may be demonstrated by clinical signs and symptoms and need not be confirmed by culture or serologic testing. However, if culture or serologic testing is performed, and the viral illness is attributed to the vaccine-strain measles virus, the presumption of causation will remain in effect. Bone marrow examination, if performed, must reveal a normal or an increased number of megakaryocytes in an otherwise normal marrow.

(8) *Vaccine-strain measles viral disease*. This term is defined as a measles illness that involves the skin and/or another organ (such as the brain or lungs). Measles virus must be isolated from the affected organ or histopathologic findings characteristic for the disease must be present. Measles viral strain determination may be performed by methods such as polymerase chain reaction test and vaccine-specific monoclonal antibody. If strain determination reveals wild-type measles virus or another, non-vaccine- strain virus, the disease shall not be considered to be a condition set forth in the Table. If strain determination is not done or if the strain cannot be identified, onset of illness in any organ must occur within 12 months after vaccination.

(9) *Vaccine-strain polio viral infection*. This term is defined as a disease caused by poliovirus that is isolated from the affected tissue and should be determined to be the vaccine-strain by oligonucleotide or polymerase chain reaction. Isolation of poliovirus from the stool is not sufficient to establish a tissue specific infection or disease caused by vaccine-strain poliovirus.

(10) *Shoulder injury related to vaccine administration (SIRVA)*. SIRVA manifests as shoulder pain and limited range of motion occurring after the administration of a vaccine intended for intramuscular administration in the upper arm. These symptoms are thought to occur as a result of unintended injection of vaccine antigen or trauma from the needle into and around the underlying bursa of the shoulder resulting in an inflammatory reaction. SIRVA is caused by an injury to the musculoskeletal structures of the shoulder (e.g. tendons, ligaments, bursae, etc.). SIRVA is not a neurological injury and abnormalities on neurological examination or nerve conduction studies (NCS) and/or electromyographic (EMG) studies would not support SIRVA as a diagnosis (even if the condition causing the neurological abnormality is not known). A vaccine recipient shall be considered to have suffered SIRVA if such recipient manifests all of the following:

(i) No history of pain, inflammation or dysfunction of the affected shoulder prior to intramuscular vaccine administration that would explain the alleged signs, symptoms, examination findings, and/or diagnostic studies occurring after vaccine injection;

(ii) Pain occurs within the specified time-frame;

(iii) Pain and reduced range of motion are limited to the shoulder in which the intramuscular vaccine was administered; and

(iv) No other condition or abnormality is present that would explain the patient's symptoms (e.g. NCS/EMG or clinical evidence of radiculopathy, brachial neuritis, mononeuropathies, or any other neuropathy).

(11) *Disseminated varicella vaccine-strain viral disease*. Disseminated varicella vaccine-strain viral disease is defined as a varicella illness that involves the skin beyond the dermatome in which the vaccination was given and/or disease caused by vaccine-strain varicella in another organ. For organs other than the skin, the disease must be demonstrated in the involved organ and not just through mildly abnormal laboratory values. If there is involvement of an organ beyond the skin, and no virus was identified in that organ, the involvement of all organs must occur as part of the same, discrete illness. If strain determination reveals wild-type varicella virus or another, non-vaccine-strain virus, the viral disease shall not be considered to be a condition set forth in the Table. If strain determination is not done or if the strain cannot be identified, onset of illness in any organ must occur 7- 42 days after vaccination.

(12) *Varicella vaccine-strain viral reactivation disease*. Varicella vaccine-strain viral reactivation disease is defined as the presence of the rash of herpes zoster with or without concurrent disease in an organ other than the skin. Zoster, or shingles, is a painful, unilateral, pruritic rash appearing in one or more sensory dermatomes. For organs other than the skin, the disease must be demonstrated in the involved organ and not just through mildly abnormal laboratory values. There must be laboratory confirmation that the vaccine-strain of the varicella virus is present in the skin or in any other involved organ, for example by oligonucleotide or polymerase chain reaction. If strain determination reveals wild- type varicella virus or another, non-vaccine-strain virus, the viral disease shall not be considered to be a condition set forth in the Table.

(13) *Vasovagal syncope*. Vasovagal syncope (also sometimes called neurocardiogenic syncope) means loss of consciousness (fainting) and postural tone caused by a transient decrease in blood flow to the brain occurring after the administration of an injected vaccine. Vasovagal syncope is usually a benign condition but may result in falling and injury with significant sequela. Vasovagal syncope may be preceded by symptoms such as nausea, lightheadedness, diaphoresis, and/or pallor. Vasovagal syncope may be associated with transient seizure-like activity, but recovery of

orientation and consciousness generally occurs simultaneously with vasovagal syncope. Loss of consciousness resulting from the following conditions will not be considered vasovagal syncope: organic heart disease, cardiac arrhythmias, transient ischemic attacks, hyperventilation, metabolic conditions, neurological conditions, and seizures. Episodes of recurrent syncope occurring after the applicable time period are not considered to be sequela of an episode of syncope meeting the Table requirements.

(14) *Immunodeficient recipient*. Immunodeficient recipient is defined as an individual with an identified defect in the immunological system which impairs the body's ability to fight infections. The identified defect may be due to an inherited disorder (such as severe combined immunodeficiency resulting in absent T lymphocytes), or an acquired disorder (such as acquired immunodeficiency syndrome resulting from decreased CD4 cell counts). The identified defect must be demonstrated in the medical records, either preceding or postdating vaccination.

(15) *Guillain-Barré Syndrome (GBS)*. (i) GBS is an acute monophasic peripheral neuropathy that encompasses a spectrum of four clinicopathological subtypes described below. For each subtype of GBS, the interval between the first appearance of symptoms and the nadir of weakness is between 12 hours and 28 days. This is followed in all subtypes by a clinical plateau with stabilization at the nadir of symptoms, or subsequent improvement without significant relapse. Death may occur without a clinical plateau. Treatment related fluctuations in all subtypes of GBS can occur within 9 weeks of GBS symptom onset and recurrence of symptoms after this time-frame would not be consistent with GBS.

(ii) The most common subtype in North America and Europe, comprising more than 90 percent of cases, is acute inflammatory demyelinating polyneuropathy (AIDP), which has the pathologic and electrodiagnostic features of focal demyelination of motor and sensory peripheral nerves and nerve roots. Another subtype called acute motor axonal neuropathy (AMAN) is generally seen in other parts of the world and is predominated by axonal damage that primarily affects motor nerves. AMAN lacks features of demyelination. Another less common subtype of GBS includes acute motor and sensory neuropathy (AMSAN), which is an axonal form of GBS that is similar to AMAN, but also affects the sensory nerves and roots. AIDP, AMAN, and AMSAN are typically characterized by symmetric motor flaccid weakness, sensory abnormalities, and/or autonomic dysfunction caused by autoimmune damage to peripheral nerves and nerve roots. The diagnosis of AIDP, AMAN, and AMSAN requires:

(A) Bilateral flaccid limb weakness and decreased or absent deep tendon reflexes in weak limbs; (B) A monophasic illness pattern;

(C) An interval between onset and nadir of weakness between 12 hours and 28 days;

(D) Subsequent clinical plateau (the clinical plateau leads to either stabilization at the nadir of symptoms, or subsequent improvement without significant relapse; however, death may occur without a clinical plateau); and,

(E) The absence of an identified more likely alternative diagnosis.

(iii) Fisher Syndrome (FS), also known as Miller Fisher Syndrome, is a subtype of GBS characterized by ataxia, areflexia, and ophthalmoplegia, and overlap between FS and AIDP may be seen with limb weakness. The diagnosis of FS requires:

(A) Bilateral ophthalmoparesis;

(B) Bilateral reduced or absent tendon reflexes;

(C) Ataxia;

(D) The absence of limb weakness (the presence of limb weakness suggests a diagnosis of AIDP, AMAN, or AMSAN);

(E) A monophasic illness pattern;

(F) An interval between onset and nadir of weakness between 12 hours and 28 days;

(G) Subsequent clinical plateau (the clinical plateau leads to either stabilization at the nadir of symptoms, or subsequent improvement without significant relapse; however, death may occur without a clinical plateau);

(H) No alteration in consciousness;

(I) No corticospinal track signs; and

(J) The absence of an identified more likely alternative diagnosis.

(iv) Evidence that is supportive, but not required, of a diagnosis of all subtypes of GBS includes electrophysiologic findings consistent with GBS or an elevation of cerebral spinal fluid (CSF) protein with

a total CSF white blood cell count below 50 cells per microliter. Both CSF and electrophysiologic studies are frequently normal in the first week of illness in otherwise typical cases of GBS.

(v) To qualify as any subtype of GBS, there must not be a more likely alternative diagnosis for the weakness.

(vi) Exclusionary criteria for the diagnosis of all subtypes of GBS include the ultimate diagnosis of any of the following conditions: chronic immune demyelinating polyradiculopathy (CIDP), carcinomatous meningitis, brain stem encephalitis (other than Bickerstaff brainstem encephalitis), myelitis, spinal cord infarct, spinal cord compression, anterior horn cell diseases such as polio or West Nile virus infection, subacute inflammatory demyelinating polyradiculoneuropathy, multiple sclerosis, cauda equina compression, metabolic conditions such as hypermagnesemia or hypophosphatemia, tick paralysis, heavy metal toxicity (such as arsenic, gold, or thallium), drug-induced neuropathy (such as vincristine, platinum compounds, or nitrofurantoin), porphyria, critical illness neuropathy, vasculitis, diphtheria, myasthenia gravis, organophosphate poisoning, botulism, critical illness myopathy, polymyositis, dermatomyositis, hypokalemia, or hyperkalemia. The above list is not exhaustive.

(d) *Glossary for purposes of paragraph (c) of this section—(1) Chronic encephalopathy.* (i) A chronic encephalopathy occurs when a change in mental or neurologic status, first manifested during the applicable Table time period as an acute encephalopathy or encephalitis, persists for at least 6 months from the first symptom or manifestation of onset or of significant aggravation of an acute encephalopathy or encephalitis.

(ii) Individuals who return to their baseline neurologic state, as confirmed by clinical findings, within less than 6 months from the first symptom or manifestation of onset or of significant aggravation of an acute encephalopathy or encephalitis shall not be presumed to have suffered residual neurologic damage from that event; any subsequent chronic encephalopathy shall not be presumed to be a sequela of the acute encephalopathy or encephalitis.

(2) *Injected* refers to the intramuscular, intradermal, or subcutaneous needle administration of a vaccine.

(3) *Sequela* means a condition or event which was actually caused by a condition listed in the Vaccine Injury Table.

(4) *Significantly decreased level of consciousness* is indicated by the presence of one or more of the following clinical signs:

(i) Decreased or absent response to environment (responds, if at all, only to loud voice or painful stimuli);

(ii) Decreased or absent eye contact (does not fix gaze upon family members or other individuals); or

(iii) Inconsistent or absent responses to external stimuli (does not recognize familiar people or things).

(5) *Seizure* includes myoclonic, generalized tonic-clonic (grand mal), and simple and complex partial seizures, but not absence (petit mal), or pseudo seizures. Jerking movements or staring episodes alone are not necessarily an indication of seizure activity.

(e) *Coverage provisions.* (1) Except as provided in paragraph (e)(2), (3), (4), (5), (6), (7), or (8) of this section, this section applies only to petitions for compensation under the program filed with the United States Court of Federal Claims on or after February 21, 2017.

(2) Hepatitis B, Hib, and varicella vaccines (Items VIII, IX, and X of the Table) are included in the Table as of August 6, 1997.

(3) Rotavirus vaccines (Item XI of the Table) are included in the Table as of October 22, 1998.

(4) Pneumococcal conjugate vaccines (Item XII of the Table) are included in the Table as of December 18, 1999.


(5) Hepatitis A vaccines (Item XIII of the Table) are included on the Table as of December 1, 2004.

(6) Trivalent influenza vaccines (Included in item XIV of the Table) are included on the Table as of July 1, 2005. All other seasonal influenza vaccines (Item XIV of the Table) are included on the Table as of November 12, 2013.

(7) Meningococcal vaccines and human papillomavirus vaccines (Items XV and XVI of the Table) are included on the Table as of February 1, 2007.

(8) Other new vaccines (Item XVII of the Table) will be included in the Table as of the effective date of a tax enacted to provide funds for compensation paid with respect to such vaccines. An amendment to this section will be published in the FEDERAL REGISTER to announce the effective date of such a tax.

It's also why, in order to determine whether a given intervention in autism has any real effect, randomized controlled trials are required. Indeed, it's not so difficult to see why, if you take into account the widespread belief that autistic children do not improve, along with parents' imperfect human memories riddled with confirmation bias, confusing correlation with causation, and other confounders like regression to the mean, so many parents believe that "autism biomed" treatments have actually helped their children. Moreover, improvements observed in autistic children tend to be uneven, with periods of little change interspersed with periods of rapid development.*
